Disaster related statistics framework

(Thailand National e-Learning course)

20 June - 8 September 2023

INVITATION

I am pleased to inform you that the e-Learning course on the "Disaster related statistics framework", in Thai language, will be conducted from 20 June – 8 September 2023. The course is being jointly organized by the United Nations Economic and Social Commission for Asia and the Pacific (Statistical Institute for Asia and the Pacific and Statistics Division), and Department of Disaster Prevention and Mitigation, Ministry of Interior of Thailand.

The collection, compilation and utilization of disaster related statistics are a priority for many countries including Thailand due to the significant impact of disasters on life, well-being and sustainable development. At the national and sub-national levels timely and accurate disaster related statistics are needed to support countries in all phases of the disaster risk management cycle from risk assessment to recovery. At the international level, the adoption of the Sendai Framework for Disaster Risk Reduction 2015-2030 has also led to increased demands for monitoring disasters. To support countries in responding to the increased needs for integrated statistics about disasters, the UN Economic and Social Commission for Asia and the Pacific (ESCAP) developed the "Disaster-related Statistics Framework" (DRSF). The framework was endorsed by the ESCAP Statistics Committee and is the focus of this e-learning course.

This course in Thai language aims to build national capacities for the compilation of disaster related statistics for enhancing disaster management and promote the risk-informed sustainable development in Thailand. The course also aims to facilitate national monitoring and reporting on

It introduces concepts relevant to compiling disaster related statistics.

The course consists of online modules and online discussion forums. The online modules provide an overview of several topics including measuring disaster risk, measuring economic losses and disaster-risk reduction expenditures. Online discussion forums will provide a venue allow participants to interact with each other and ask questions. Target participants are government officials and experts in the national disaster management as well as the statistical system in Thailand. The course can also be useful to a wider audience who is interested to learn more about disaster related statistics.
