Template for national strategy for action for transforming official statistics in support of the 2030 development agenda

Data and Statistics Demands raised by SDGs

- SDGs has came into effect on 1 January 2016 with a much broader ambit in terms of scope and coverage than the data requirements under MDGs.
- Fulfilment under SDG commitment places new demands on quality data and statistics, disaggregated by location, sex, age, income group and other dimensions of development.
- This can be achievable only with the active involvement of all stakeholders including the subject Ministries and State/UT Governments in a coordinated efforts manner in developing a broad statistical indicator framework to make available key indicators as part of the SDG requirements.
- Major investments are also required on statistical instruments, such as censuses, household/establishment surveys, statistics for local level development, strengthening civil and sample registration systems and also compiling relevant statistics from existing administrative records.
- increase use of ICT tools for faster dissemination of results.
