

Importance of Service Industries in Hong Kong

- Proportion of GDP: over 90%
- Ratio of exports of services to GDP: about 30%

Retail Sales

- Released on a monthly basis
- Monthly Survey of Retail Sales
 - Sample size:
 - $\succ 3~000$ retail establishments
 - Sampling method:
 - » Stratified rotational replicate sample design
 - For each month, 3 replicates are used, with one new replicate rotated in and one replicate rotated out
- Release statistics
 - Value of retail sales by types of retail outlet
 - Value index of retail sales by types of retail outlet
 - Volume index of retail sales by types of retail outlet
 - Quarter-to-quarter rate of change of 3-month period seasonally adjusted series

Restaurant Receipts


- Released on a quarterly basis
- o Quarterly Survey of Restaurant Receipts and Purchases
 - Sample size:
 - > 1 100 restaurants
 - Sampling method:
 - > Stratified rotational replicate sample design
 - For each month, 6 replicates are used, with 3 new replicates rotated in and 3 replicates rotated out
- Release statistics
 - Value of restaurant receipts and purchases
 - Value index of restaurant receipts by types of restaurant
 - Volume index of restaurant receipts by types of restaurant
 - Quarter-to-quarter rate of change of seasonally adjusted restaurant receipts

Business Receipts Indices

- Released on a quarterly basis
- Main data source: Quarterly Survey of Service Industries
 - Sample size:
 - $ightarrow 5\ 000\ establishments\ engaging\ 5\ or\ more\ persons$
 - Sampling method:
 - > Stratified rotational replicate sample design
 - > At least half of the sampled establishments in the current quarter were enumerated in the last quarter
- Release statistics
 - Business receipts indices for 22 selected industries and 2 service domain
 - Quarter-to-quarter rate of change in business receipts indices

Producer Price Indices

- Released on a quarterly basis
- Data source
 - Quarterly Survey of Service Industries
 - Consumer Price Index system
- Release statistics
 - Producer price indices for 14 selected industries




- Imports and exports of goods involved in processing without a "change of ownership" to be excluded from trade in goods
- Payment of processing fees to the processing economy should be recorded as imports of services

Trade in services

Enhancement on the Monthly Survey on Trade Involving outward Processing in the Mainland

- Value of processing fees paid by Hong Kong
- Value of raw-materials/ semi-manufactures sent to the Mainland with breakdown into
 - those procured by Hong Kong and exported from Hong Kong
 - those procured by Hong Kong and exported from places other than Hong Kong
 - those procured by the Mainland processing units



Trade in services

2008 SNA: Merchanting

- NOT recorded as exports of services
- Acquisition of goods abroad for "merchanting" is recorded as <u>negative exports of goods</u> and the subsequent resale of goods is recorded as <u>exports</u> <u>of goods</u>


