A webinar session to mark the fiftieth anniversary of the Institute was held on 24 August 2020. The session was held on the topic '50 years of Statistical Capacity Building by UN Statistical Institute for Asia and the Pacific (SIAP): Perspectives from Alumni Chief Statisticians' and, was organised in the context of the Committee on Statistics..

The session was opened by Ms Armida Salsiah Alisjahbana, United Nations Under-Secretary-General and Executive Secretary of ESCAP and, was moderated by the Director, SIAP. The panel for discussion included alumni Chief Statisticians/ Heads of national statistical offices from Lao People's Democratic Republic, Malaysia and Sri Lanka, Director General, International Statistical Affairs, Ministry of Internal Affairs and Communications of Japan, representing the host agency of the Institute and Director, Statistics Division of ESCAP.

Webinar session on 'Challenges of measuring the mortality of COVID-19 Pandemic' |20 August 2020|

The session provided insights into the advantages and limitations of metrics used in measuring the risk of losing life from COVID-19 and, to share experiences in measuring excess mortality and the multi-dimensional aspects of COVID-19. Officials from national statistical offices as well as from the Ministry of Health and related agencies participated in the session. Dr Raffaele Vardavas from RAND Corporation, Dr Sarah Nowak from Larner College of Medicine at the University of Vermont as well as Dr Reiko Hayashi from Japan National Institute of Population and Social Security Research were guest speakers.

Intermediate level e-learning course on the System of National Accounts (SNA): Integrated transaction accounts

Ninety-five government officials accessed this course. A webinar session was delivered on 27 July by Mr Rajiv Sharma as a guest speaker on the topic 'Main macroeconomic aggregates in the SNA'. Mr Sharma, currently, Vice President of Indian Association of Research in Income and Wealth, worked for the Indian government, as a statistician in various areas of official statistics and has specialised in national accounts statistics and revenue statistics. He also worked as a national accounts expert in Middle East.

Another webinar session was held on 17 August delivered by the Director, SIAP on the topic 'COVID-19 recording options and their impact on key national accounts aggregates'.
