

Crime Statistics from a Gender Perspective 3.0

(Facilitated e-Learning course)

18 August – 3 October 2025

Concept Note

I. OVERVIEW OF THE COURSE

This e-learning course introduces crime statistics from a gender perspective to produce reliable indicators to monitor the relevant Sustainable Development Goals (SDGs). The course offers participants an opportunity to explore gender concepts and frameworks on SDG indicators relevant to crime and criminal justice statistics including gender-based SDG targets, with the overall aim of strengthening regional capacity in producing high-quality SDG indicator data and overall statistics, to inform policy decisions at national and international levels.

This course is the third of its kind and builds on the content covered in the two previous e-learning courses from 2020 and 2022. This iteration of the course includes updated versions of the four modules from previous courses to reflect recent developments in crime and gender statistics. Additionally, it introduces two new modules: "Gender-related killing of women and girls (femicide/feminicide)" and "Technology-facilitated Violence against Women." Participants who completed earlier versions of this course will have the opportunity to refresh their knowledge and explore recent developments in crime statistics.

The content of this e-learning course has been jointly developed by the United Nations Office on Drugs and Crime (UNODC), the UNODC-KOSTAT Centre of Excellence for Statistics on Crime and Criminal Justice in Asia and the Pacific (UNODC-KOSTAT CoE), the United Nations Statistical Institute of Asia and the Pacific (SIAP) and the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women) Knowledge and Partnerships Centre in the Republic of Korea.

II. TARGET PARTICIPANTS

The target participants for this course are personnel working in the field of crime and criminal justice statistics, whose main responsibilities include collection, production, analysis or dissemination of crime-related statistics and indicators. The course is also open to policy and decision makers who are looking to understand the concepts and methodological details behind crime-gender related SDG indicators and to interpret them accurately to use data for evidence-based decision making.

There are no prerequisites for this course, however familiarity with the [2030 Agenda for Sustainable Development](#) and the related [SDG Indicator Framework](#) would be advantageous.

III. LEARNING OUTCOMES

By the end of the course, participants will be expected to:

- Understand the importance of incorporating a gender perspective in collecting, producing, analyzing, and disseminating crime statistics.
- Apply tools and frameworks to improve the production, collection, analysis, and dissemination of crime data from a gender perspective.
- Analyze the opportunities and challenges of working with various types of data sources.
- Evaluate the relationship between data, crime, and gender at national, regional, and international levels.
- Understand recent global initiatives and statistical frameworks aimed at measuring technology-facilitated violence against women (TFVAW) and the gender-related killing of women and girls.
- Create capacity to produce gender and crime-related SDG indicators using microdata.

IV. COURSE DESIGN AND CONTENT

This course includes 6 mandatory online modules, each featuring interactive slides, detailed explanations of key concepts, basic coverage of the tools available to help improve statistical capacity, and practical advice based on national examples showing different challenges and successes.

The interactive content is hosted on the [SIAP e-learning portal](#), where participants must complete the modules synchronously. The modules should take up to 9 hours (approximately 90 minutes of seat time per module) to complete. The course will feature a discussion forum which will be hosted in the e-learning portal and be a platform to pose general questions and facilitate substantive discussions and interactions with other participants and organizing agencies. Active participation in the online forum is encouraged, with discussion topics posted regularly. Details on accessing the SIAP LMS and webinar schedules will be communicated to registered participants at the course's start.

Participants are also required to attend live three expert-led webinars (each approximately 60 minutes in duration) that complement the e-learning modules. The dates and further guidelines will be communicated separately via email to registered participants.

V. EVALUATION

Participants' understanding of the course material will be reinforced through integrated mini quizzes in each interactive module as well as a final assessment upon completion of all 6 modules.

Participants will be eligible to receive a certificate of completion upon (i) attaining a minimum grade of 70% in the final assessment; and (ii) completing the course evaluation (feedback) questionnaire. Participants may take the final test up to three times and retain their best score. Participants may not work together on the test. The course facilitator reserves the right to deny course certificates to participants suspected of cheating on the test.
