



## **Implementation of UN Sustainable Development Goals (SDGs) in the Republic of Uzbekistan**

### **1. Accepted country programmes**

- ❖ Short-term (Annual and 5-year country and regional development programmes);
- ❖ Annual social programmes for the improvement of welfare of the population and its ethnic minority groups (children, women, vulnerable segments of the population);
- ❖ Annual Government-funded quick-impact project programmes on national and regional levels;
- ❖ Medium-term (3-5 years) development programmes on economic sectors;
- ❖ Sectoral programmes, focused on developing separate sectors.

## 1. Accepted country programmes (continued)



- ❖ Forecast of socio-economic development sectors and regions
- ❖ Country-wide development programmes/strategies:
  - Socio-Economic Development Strategy of Uzbekistan for the period until 2030.
  - Improvement of Population Welfare Strategy of the Republic of Uzbekistan for 2013–2015.
  - Programme for Implementation of the National MDGs in Uzbekistan for 2000-2015.
  - Environmental programmes (Aral problem, climate change, water management)

## Government programmes



- ❖ Government programmes are developed with the objective of implementing specific priorities and meeting the challenges of economic policies;
  - ❖ Objectives (target indicators) and targets of government programmes are established;
  - ❖ Specific actions/measures for addressing specific challenges, focusing on achieving objectives of the Government programmes, are developed;
  - ❖ Timeline and responsible stakeholders for activity implementation are identified (each activity is assigned one or several ministries and departments, by the ministerial working groups and others.);
  - ❖ Valuation of the programme is produced with cost measurement of financial sources for each activity;
  - ❖ Sources of funding for programme activities sources are formulated;
  - ❖ Monitoring system for programme activity implementation is established for separate stakeholders with the provision of reliable statistics and reporting. For the process of monitoring, the initial and final (result) indicators are used for achieving the tasks of each activity (both for absolute and relative indicators);.

### 3. Programme monitoring



- ❖ The important step for organizing programme monitoring is to formulate institutional capacities, which is necessary for funding support.
- ❖ A monitoring group, consisting of specialists of key ministries and national departments, is established to conduct the monitoring.
- ❖ Collection, analysis and processing of data, as well as the feasibility of the attained measures, aid in the preparation of periodic reports.

### 3. Programme monitoring



Monitoring and assessment are organized on different levels:

- a) Macro level;
- б) Local (regional) level;
- в) Sectoral level.

herewith:

- ❖ On the macro level, data is collected and compiled from both regions and sectors;
- ❖ On the sectoral level, the analysis of the achieved sectoral activity results, linked to macroeconomic indicators, is used, which allows to identify whether the objectives and intended results in the development of sectors of the real sector are achieved, while at the same time assesses the progress on the implementation of government policies.

#### **4. Government programmes for the implementation of national SDGs**



The government of the republic of Uzbekistan supports the UN recommendations and has put a priority on setting up a focused system of adapting the global SDGs to the country context, through the development of a national agenda for sustainable development, with national goals, targets, and indicators for progress monitoring in SDG implementation, and based on this, aims to develop the government programme for the implementation of national SDGs.

#### **4. Government programmes for the implementation of national SDGs**



With this objective, the corresponding decree №111-F was passed by the Cabinet of Ministers of the Republic of Uzbekistan on 15 February 2016, stating the following:

- Establishment of a coordinating Council for the development and implementation of measures for the adaptation of UN Sustainable Development Goals;
- Establishment of six thematic working groups for the development and implementation of measures for the adaptation of UN Sustainable Development Goals in the areas of economic welfare, social protection, health, education, environment and effective management;

#### 4. Government programmes for the implementation of national SDGs (*continued*)



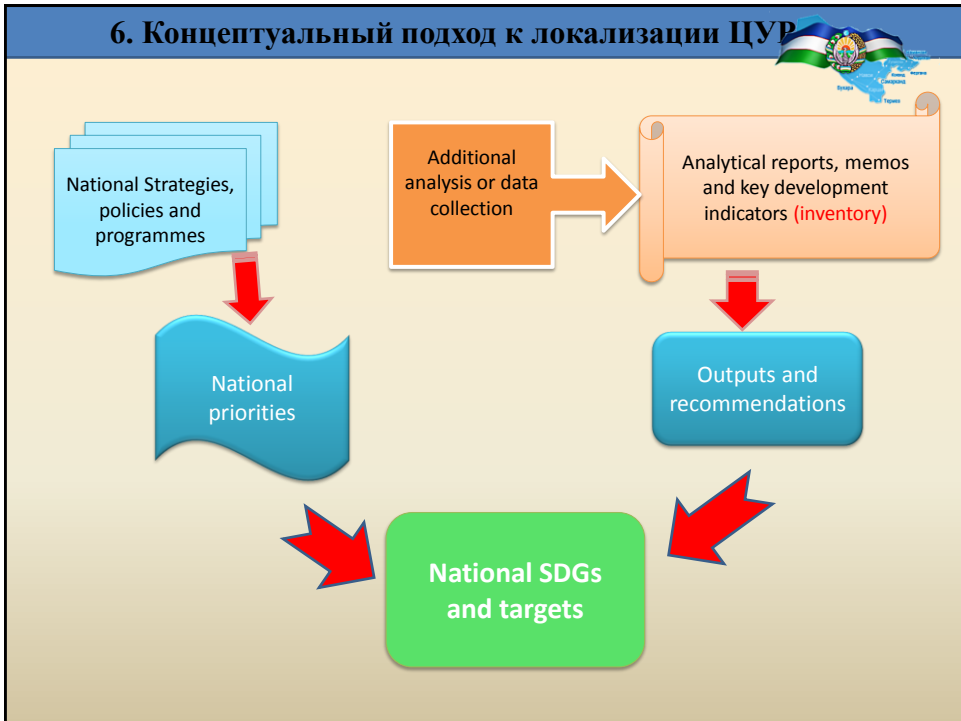
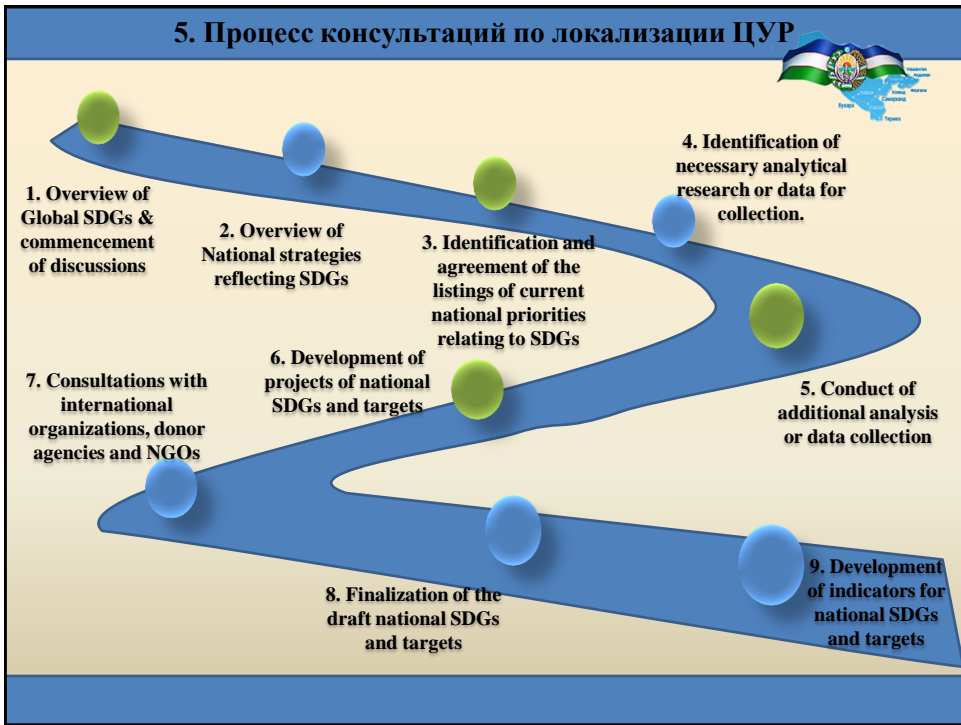
- The working groups are developed on the basis of the approved thematic working groups for the development of the UN Framework Programme in support of the Republic of Uzbekistan with the objective of development for the period of 2016-2020 (UNDAF);
- The working plan on the adaptation of the UN Sustainable Development Goals and the list of tasks on the implementation of the UN Sustainable Development Goals was enacted and considered under approved thematic working groups.

#### 4. Government programmes for the implementation of national SDGs




Following the order of the government:

- An Integrated Programme for the implementation of SDGs in Uzbekistan will be developed in early 2017
- An active working group, consisting of specialists from the State Statistics Committee as well as specialists from relevant national ministries and departments, shall be established by the Government committee of the Republic of Uzbekistan for the purpose of monitoring and assessment of national indicators of the Sustainable Development Goals.



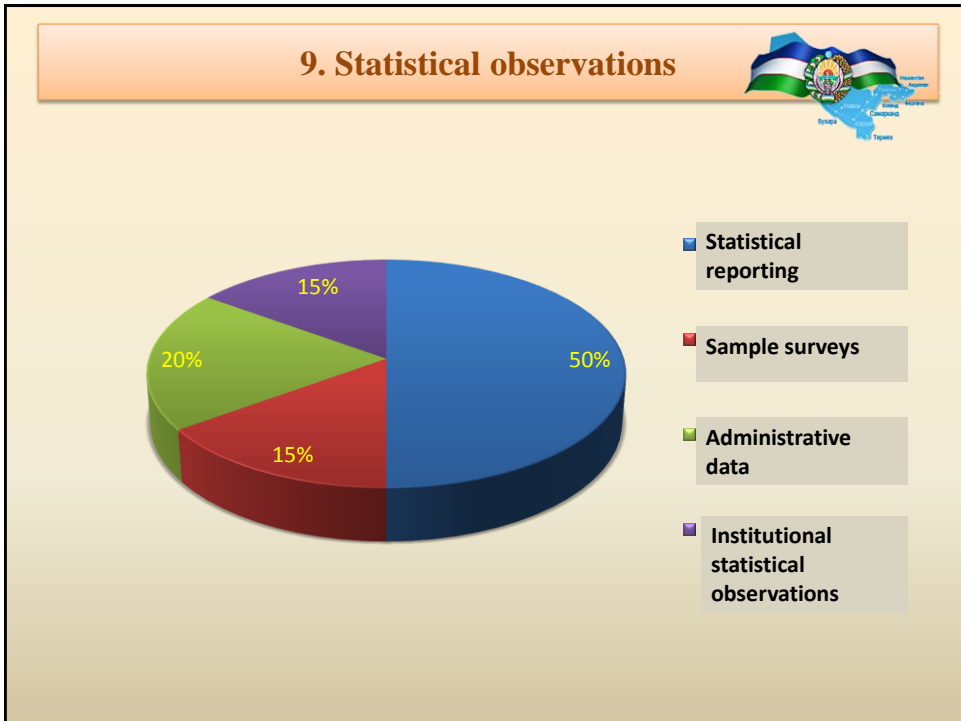
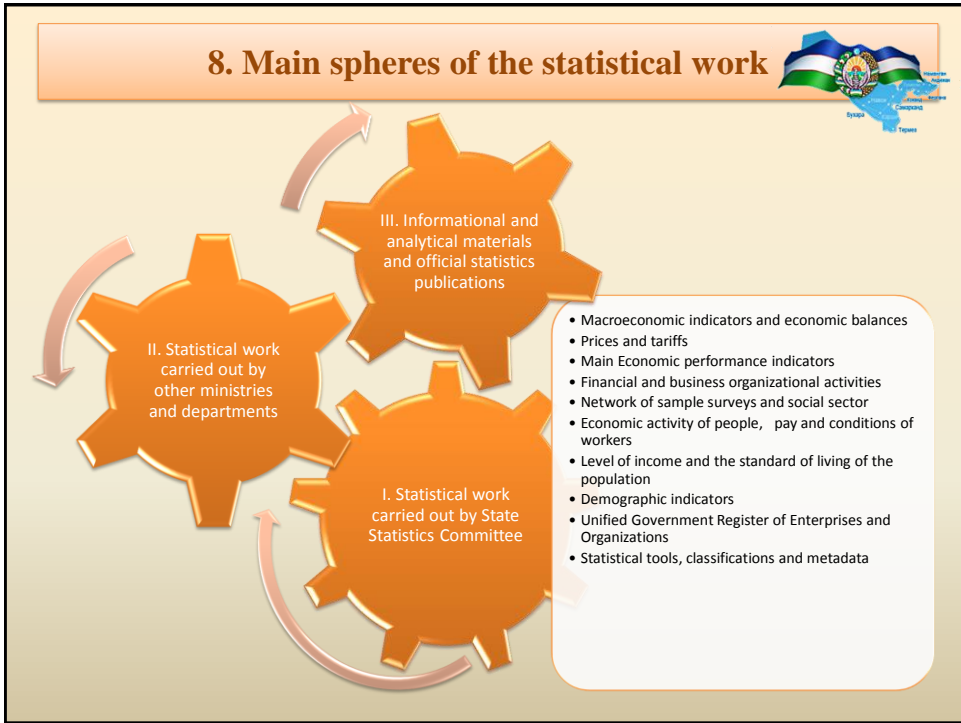
