MDGs

- 8 Goals, 21 Targets, 60 Indicators
- Basic development
- Focus on developing countries
- Focus on quantity
- Environment is secondary

TO SDGs (2015 – 2035)

Sustainable Development Goals



SDGs

- 17 Goals, 169 Targets, >200 Indicators
- Inclusive, sustainable well-being
- Universal: Focus on all countries
- More comprehensive: quantity & quality
- Environment is basic to well-being

Continuation of MDGs Successes To SDGs (selected indicators):



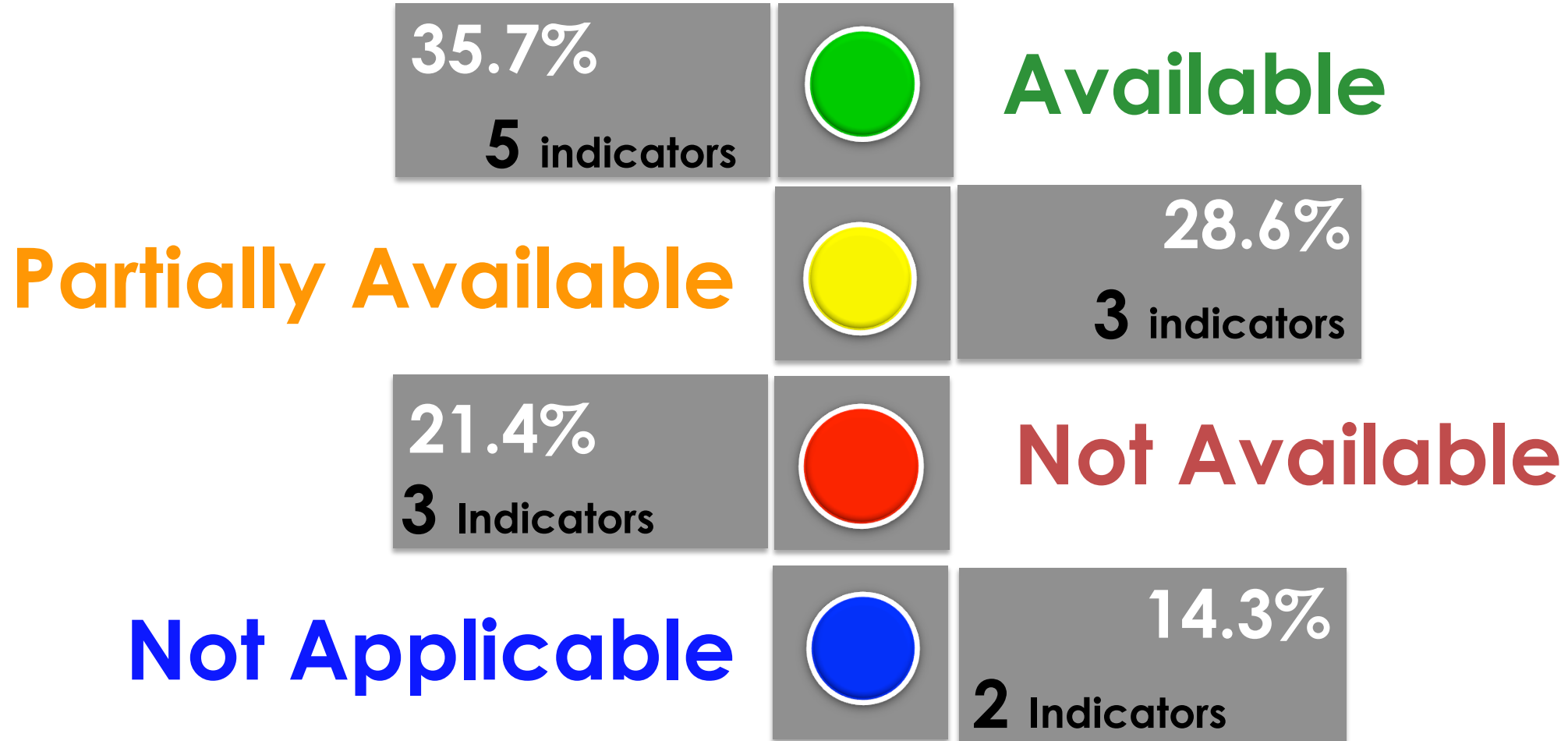
National forest reserves protected by law: 41% of total land area



Mobile penetration: 125.5%
Mobile broadband penetration: 121.2% (2016)

- **Under-5 mortality rate: 10.4 per 1,000 livebirths (2016)**
- **100% of live births attended by skilled health personnel (2016)**
- **Literacy rate: 98.6 for males and 97.4 for females (2016)**
- **Unemployment rate: 6.9 % (2014)**

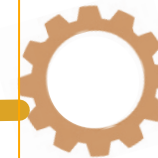

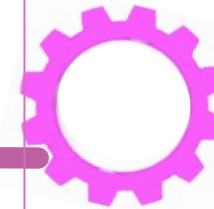

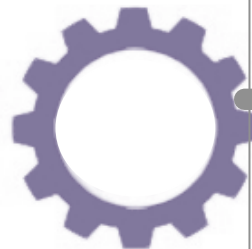
Element of disaggregation - no one left behind



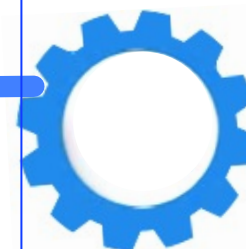
Coordination between Agencies (eg: Bilateral meeting, appointment of focal person)

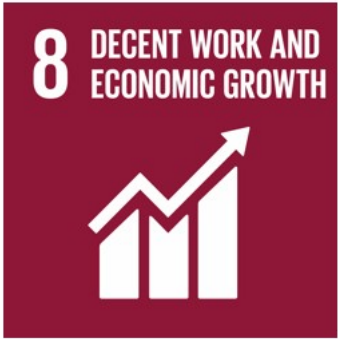
