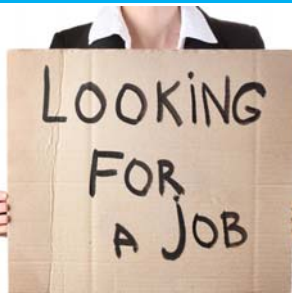

- 4.3.1 Participation rate of youth and adults in formal and non-formal education and training in the previous 12 months, by sex (Tier II)
- 8.2.1 Annual growth rate of real GDP per employed person (Tier I)
- 8.7.1 Proportion and number of children aged 5-17 years engaged in child labour, by sex and age (Tier II)
- 8.8.1 Frequency rates of fatal and non-fatal occupational injuries, by sex and migrant status (Tier II)
- 8.8.2 Level of national compliance of labour rights (freedom of association and collective bargaining) based on International Labour Organization (ILO) textual sources and national legislation, by sex and migrant status (Tier III)

Current Challenges

- **Current indicators provided by Indonesia LFS (Sakernas) are still using older ILO or other concepts**
 - Concept of work is using ICLS 13
 - Informal work is still using old concept
- **Disaggregation still not possible for some indicators**
 - Sample size
 - Not in the questionnaire (international migrant status)
- **Child labour indicators has not been conducted (only pilot)**
- **Administrative data still incomplete**
- **Political Issues**

- **More efforts to calculate more SDGs indicators**
 - From other household surveys (indicator 1.1.1 using the socio-economic survey)
 - From other units in NSO (indicator 8.2.1 & 10.4.1. from national accounts unit)
 - From administrative data (indicator 1.3.1 from the social security agency)
 - Increase sample size of Sakernas to improve disaggregation (ex. disability)
 - Technical assistance from ILO to conduct special surveys to collect SDGs indicators (i.e., child labour survey every five years)
- **Efforts to apply the new concepts**
 - Coordination between government institutions
 - Socialization
 - Technical assistance from ILO to push for application of new concept
