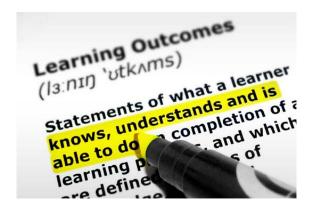

5 Elements of a Good Advocacy Issue

- Experience and unique expertise. Existing objective or natural outgrowth of your organization.
- Evidence-based. Existing proof that the issue is a problem. More varied, more effective.
- Significant impact if addressed. Change in policy or implementation of a policy helps to improve the problem.
- Success feasible in 3-5 years.
- Clear and specific. More specific and clear, better able to develop a policy solution.


There are many problem in the world (and in ARS).

Policy advocacy is NOT ALWAYS the best strategy to solve a problem.

If a problem can be solved by a programme (actions within your control), then it is not an ideal focus for a policy advocacy strategy.

Vicious Circle Countries

- Weak statistics
- Evidence-based policy making is not practiced
- Poor policy decisions
- Poor development outcomes

Scope and Outcome of Global Strategy

- Why? To address identified weaknesses in basic data and availability of information
- Expected Result? Countries have sustainable systems to produce accurate and reliable data to inform and guide policy analysis and decision making

Regional Action Plan [RAP] = Implementing Mechanism



Common Findings from IdCA

- Lack of integration of agricultural and rural statistics into NSS contributed to their decline in quantitative and qualitative terms
- Data are produced by several line ministries and agencies: difficulties in coordinating, lack of standards, duplications of work
- Scarce awareness of data producers on users needs and policy initiatives
- * Policy makers make little use of available data



DESIRED CHANGES for ARS Systems

Examples:

- Integrate evidence-based policy of statistics into policy frameworks
- Improved awareness & use of statistics
- Organizational and institutional change
- Achieve better allocation of resources and increase aid effectiveness through statistics
- Obtain appropriate and sustained financing from national budgets
- Improve coordination between donors
- Increase financial and technical assistance from donors



Our Definition

... deliberate process of informing and influencing decision-makers in support of evidence-based policy change and policy implementation, including resource mobilization.
