### Regional Course on Informality: Definitions, Measurement, SDGs and Other Policy Indicators [16-20 October 2017 | Chiba, Japan]



This course started on 16 October in collaboration with ILO and WIEGO (Women in Informal Employment: Globalizing and Organizing). Twenty five statisticians and officials of Ministry of labour from the following 14 countries attended the programme. Brunei Darussalam, Cambodia, China, Fiji, India, Indonesia, Lao PDR, Myanmar, Mongolia, Philippines, Samoa, Sri Lanka, Thailand and Viet Nam.

Statisticians and Labour policy analysts discussed technical issues related to measurement of informality and compilation of SDG related indicators sharing experiences in the production and use of statistics on informality.
